Calhoun County --- Requested service area: the area of the county starting from the city limits of the City of Blountstown and going out in any direction for a distance of two (2) miles. Gadsden County --- Requested service area: the area of the county consisting of a one (1) mile strip on either side of State Highway 269 beginning at the Chattahoochee city limits and going south along State Highway 269 for two and one-half (2 1/2) miles. Effective date of operations --- BHN currently provides cable service in each of these communities.
