

Bright House Networks served each of these communities pursuant to a locally issued franchise. The service areas will be co-extensive with the descriptions contained in those agreements.

Gadsden County, Requested service area: the area of the county consisting of a one (1) mile strip on either side of State Highway 269 beginning at the Chattahoochee city limits and going south along State Highway 269 for two and one-half (2 1/2) miles. Effective date of operations, Bright House Networks currently provides cable service in each of these communities.

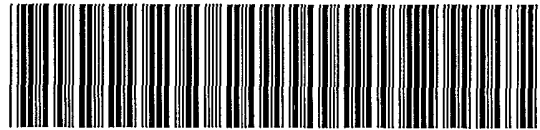
