

**AFFIDAVIT**

I, Donald R. Granger, am employed with BellSouth Entertainment in an official capacity as (officer, partner, owner, managing member) President - BellSouth Entertainment, LLC and do hereby attest to the facts stated herein from my personal knowledge. I hereby swear and affirm that the following statements are true and correct:

- 1) The applicant is fully qualified under the provision of Chapter 610, F.S., to file this application and affidavit for a certificate of franchise authority.
- 2) The applicant has filed or will timely file with the Federal Communications Commission all forms required by that agency in advance of offering cable or video services in this state.
- 3) The applicant agrees to comply with all applicable federal and state laws and regulations, to the extent such state laws and rules are not in conflict with or superseded by the provisions of Chapter 610, F.S., or other applicable state law.
- 4) The applicant agrees to comply with all the state laws rules and municipal and county ordinances and regulations regarding the placement and maintenance of communications facilities in the public rights-of-way that are generally applicable to providers of communications services in accordance with s. 337401, F.S.

5) The description of the service area consistent with s. 610.104 (2)(e) 5a & b, F.S., for which the applicant seeks a certificate of franchise authority is: City of Coconut Creek - The LFA between BEI and the City of Coconut Creek defines the franchise area to include the entire geographic area within the cable franchise jurisdiction of the City of Coconut Creek; Miami-Dade County - The LFA between BEI and Miami-Dade County defines the franchise area to include all unincorporated and incorporated areas of Dade County; Town of Davie - The LFA between BEI and Town of Davie defines the franchise area to include the entire geographic area within the cable franchise jurisdiction of the Town of Davie; Orange County - The LFA between BEI and Orange County defines the franchise area to include all of Orange County; Pembroke Pines - The LFA between BEI and Pembroke Pines defines the franchise area to include all of the geographic area within the cable franchise jurisdiction of the City of Pembroke Pines; Seminole County - The LFA between BEI and Seminole County defines the franchise area to include the entire geographic area within the cable franchise jurisdiction of Seminole County; St. Johns County - The LFA between BEI and St. Johns County defines the franchise area to include the portion of the County of St. John located within the Saint Johns Project, as well as all of the unincorporated areas of St. Johns County, Florida, except that portion: Beginning at the intersection of the shores of the Atlantic Ocean with the Southern City Limits line of South Ponte Vedra Beach and run westerly along said Southern City Limits to Shannon Road; thence continue Westerly along Shannon Road to U.S. #1; thence Southerly along U.S. #1 to Nine-Mile Road/International Golf Parkway; thence Westerly along Nine-Mile Road/International Golf Parkway to I-95 to St Johns County's Southerly line; thence Easterly along said county line to the shore of the Atlantic Ocean; thence Northerly along said shore of the Atlantic Ocean to the Point of Beginning.




