This is in reference with telephone conversation with your office today regarding the 1997 Profit Corporation Annual Report in which we pointed out that under date of January 3, 1997 we filed this Report and sent our Check No. 7171 payable to the Department of State in the amount of \$165.00, 1997 Filing Fee Not Profit Corporation for Florida Citrus Processors Association, and mailed same to Annual Reports Filing, Division of Corporations, P. O. Box 1500, Tallahassee, Florida. It became necessary for us to inquire of your office on May 2, 1997 asking that you check your records since our check was still outstanding and advise the status of the report and check.
