The above Act requires each and every corporation now organized and existing under the laws of this State, or which may hereinafter be organized under the laws of this State, and each and every Foreign Corporation which has heretofore or may hereinafter qualify under the law to transact business within the limits of the State of Florida, to designate a place of business or domicile for the service of process within this State, and name agent to accept service of process. (This Act does not apply to: Banking Companies, Trust Companies, Insurance Companies of any kind, Safety Deposit Companies, Building and Loan Associations, Express and Railroad Companies, Telephone and Telegraph Companies, Shipping and Commerce Companies, Canal Companies, Co-operative Associations, Cemetery Companies, State Fairs or Expositions, Fraternal Benefit Societies and organizations not for profit.)
Said Act, also provides that each and every corporation, not exempt, must on or before the first day of June of each year file with Secretary of State certificate showing the names of officers and directors of the corporation, and their addresses.
Said Act, also provides that in the event the corporation desires to change its office or domicile for the service of process, as herein provided, it shall at least ten days before making such change file with the Secretary of State an amendment to its certificate heretofore provided for, specifying such change and designating its new office, domicile or place of business for the service of process in the manner aforesaid.
There is a fee of \$1.00 for filing this certificate.
