STATEMENT OF CANCELLATION OF 26,100 SHARES
OF 14.38% PREFERRED STOCK, SERIES N, OF
FLORIDA POWER & LIGHT COMPANY

1. The name of the corporation is Florida Power & Light Company (the "Company")
2. As of this date, 26,100 shares of the 14.38% Preferred Stock, Series N of the Company of its class of Preferred Stock of the par value of \$100 each (the "Preferred Stock") have been purchased by the Company and cancelled.
3. After giving effect to this Statement of Cancellation, the number of shares of Preferred Stock which the Company shall have authority to issue is 19,712,900 and the number of shares of 14.38% Preferred Stock, Series N which the Company shall have authority to issue is 323,900.
