## STATEMENT OF CANCELLATION OF SHARES OF FLORIDA POWER & LIGHT COMPANY

I.

The name of the Corporation is Florida Power & Light Company.

### II.

The total number of shares cancelled are 286,000 shares of Preferred Stock, par value of \$100 per share, which shares are itemized under the following series:

150,000 shares of 10.08% Preferred Stock, Series J, par value of \$100 per share;

36,000 shares of 8.70% Preferred Stock, Series M, par value of \$100 per share;

35,000 shares of 14.38% Preferred Stock, Series N, par value of \$100 per share; and

65,000 shares of 11.32% Preferred Stock, Series O, par value of \$100 per share.

## III.

After giving effect to such cancellation, the shares which the Corporation is authorized to issue, itemized by classes and series is as follows:
