

ARTICLES OF AMENDMENT TO CERTIFICATE OF INCORPORATION **OF** BRADENTON COUNTRY CLUB, INC.

THIS AMENDMENT was adopted on October 24, 2006 by the stockholders in which the number of votes cast for this amendment was sufficient for approval, in accordance with Florida Statutes.

WITNESSETH:

WHEREAS, in 1964, Bradenton Country Club, Inc. (the "Club") adopted a debt limitation of Seven Hundred Fifty Thousand Dollars (\$750,000.00) as indicated in Club's Certificate of Amendment to Certificate of Incorporation; and

WHEREAS, it has been decided that it is in the best interest of the Club to increase the debt limitation adopted in 1964 to adjust for inflation and the cost of conducting business; and

WHEREAS, in connection with this Amendment, the First Paragraph of Article Eighth shall be deleted in its entirety and replaced as amended herein.

NOW THEREFORE, pursuant to Florida Statutes, this Florida corporation adopts the following Articles of Amendment to its Certificate of Incorporation:

> 1. The First Paragraph of Article Eighth of the Certificate of Incorporation is hereby deleted in its entirety and replaced with the following new First Paragraph of Article Eighth:

Eighth: INDEBTEDNESS

(a) The amount of the indebtedness or liability to which this corporation may at any time subject itself shall not exceed \$4,000,000.00. Such amount shall automatically increase three percent (3%) per annum from the date of adoption of this amendment.

The foregoing amendment was approved and ratified by a majority vote of stockholders of Bradenton Country Club, Inc., at a duly called meeting of the stockholders held on October 24, 2006, at which meeting a quorum was present Therefore, the Secretary of State is hereby requested to approve and file these Articles of Amendment in accordance with Florida Statutes.
