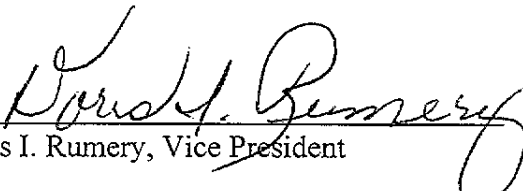

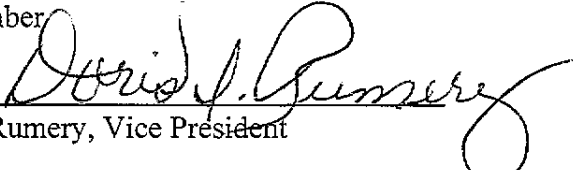
1. National Association for Stock Car Auto Racing, Inc., is a Florida corporation filed under document number 154117 and shall be referred to herein as "NASCAR".

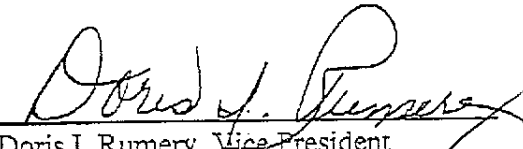

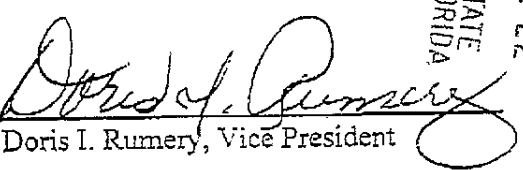
