Pursuant to Florida Statutes Section 607.1006, the Articles of Incorporation of Sunshine Laundry Inc are hereby amended as follows:

1. Article III is hereby amended to read as follows:


ARTICLE III


The maximum number of shares that this Corporation is authorized to have outstanding at any one time is one hundred thirty seven and seven tenth (137.7) shares having a par value of One Dollar (\$1.00) per share.

2. The foregoing amendment was adopted by written consent of all the Directors and all of the Shareholders pursuant to Florida Statutes Chapter 607 on May 22, 2001.

3. At this time, of the original one hundred fifty three (153) shares of the Corporation authorized and issued, fifteen and three tenths (15.3) shares have been acquired by the Corporation on August 2, 2000, leaving only one hundred thirty seven and seven tenths (137.7) shares outstanding.
