

Dear Mr. Gray:

We have your letter of October 1, 1953, in which you call to our attention the fact that Section 610.32 of the Florida statutes imposes certain restrictions upon the use of the word "club".

We have made certain amendments and corrections to the certificate of incorporation of Pompeno Surf Club, Inc., so as to conform the same to your suggestions. It is our opinion that we have complied with the statute in this amended certificate in as much as the certificate indicates that five or more persons are organizing and associating themselves "for the mutual advantages to be derived solely from social activities". The certificate further provides that the activities of the proposed corporation contemplate no profit.

We have further amended the certificate so as to provide that the total number of shares of stock subscribed shall not be less than the amount of capital with which the corporation will begin business, also pursuant to your suggestion.

We enclose herewith the certificate containing these amendments and request that you file the same.

Thank you for your helpful attention to this matter.


Dear Mr. Gray:

We received your telegram today advising us that the name Pompano Surf Club, Inc. is not available on account of the use of the word "Club".

The true purpose for which this corporation is organized is to hold title to certain real property and to operate the same as a cooperative residential development solely for the benefit of its lessees, who will also be all of the stockholders in the corporation. You will note that this appears in Paragraph (b) of Article II, of the Certificate which you have.

In view of this, please advise whether it would not be permissible to use the name Pompano Surf Club, Inc., despite the fact that the corporation intends to incorporate under the general corporation statute.

CERTIFICATE OF INCORPORATION
OF
POMPANO SURF CLUB, INC.

We, the undersigned, hereby associate ourselves together for the purpose of becoming a corporation under the Laws of the State of Florida, by and under the provisions of the Statutes of the State of Florida, providing for the formation, liability, rights, privileges and immunities of a corporation for profit.

ARTICLE I.

The name of the corporation shall be:

POMPANO SURF CLUB, INC.

ARTICLE II.

GENERAL NATURE OF BUSINESS

(a) The objects and purposes of the corporation shall be to acquire and hold title to such real and personal property as it shall require for a cooperative residential housing community, occupied solely by its stockholders, and for such cooperative community endeavors as a recreation hall, swimming pool, lawns, parks, beaches, and similar facilities. The further objects and purposes of the corporation shall be to organize and associate the stockholders together as members for the mutual advantages to be derived from social activities within the cooperative residential housing community, and to operate said community and its facilities solely for the benefit and advantage of the stockholders, and on a non-profit basis.

(b) The corporation shall have the power generally to make and perform contracts of any kind and description and for the purpose of attaining any of the objects of the corporation; to do and perform any other

act or things, and to exercise any and all powers which a co-partnership or natural person could do and exercise, and which now are or hereafter may be authorized by law, and generally to do and perform any and all things necessary or incident to the performing and carrying out of the powers hereinabove specifically delegated or implied.

ARTICLE III.

CAPITAL STOCK

The stock of this corporation shall be divided into One Thousand, Five Hundred Eighty-two (1,582) shares of stock of the par value of \$1.00 each. The amount of capital with which this corporation may commence business is the sum of Five Hundred (\$500.00) Dollars.

ARTICLE IV.

This corporation shall have perpetual existence.

ARTICLE V.

HIGHEST AMOUNT OF INDEBTEDNESS

The highest amount of indebtedness to which this corporation may obligate itself will be \$250,000.00.

ARTICLE VI.

The principal place of business of said corporation shall be at Pompano Beach, Florida.

ARTICLE VII.

NUMBER OF DIRECTORS

The number of directors of this corporation shall be not less than three, and the maximum number thereof shall be as may be fixed from time to time by the stockholders.

ARTICLE VIII.



ANNUAL CORPORATION CAPITAL STOCK TAX LAW

608.32 Annual report of corporation; contents. —

(1) All corporations heretofore or hereafter incorporated in this state and all foreign corporations heretofore or hereafter authorized to do business in this state are required to file with the secretary of state on or before July 1st of each year a sworn report, on such form as the secretary of state shall prescribe, giving (a) the name of each officer and director and his post office address, (b) the home office of the corporation, (c) the name and address of the resident agent upon whom service of process may be made, (d) the main line of business engaged in by the corporation, (e) the date of the last meeting of its board of directors, (f) whether the corporation has been actively engaged in business during the previous twelve (12) months or if its charter powers have been dormant and unused during that period, (g) the number of the shares of the capital stock of such corporation with the par value thereof, (h) the total amount of capital stock, and if a foreign corporation the amount of its capital stock allocated for use in the State of Florida, (i) such other information as may be needed to show whether the corporation is active or inactive, and (j) such other information as may be necessary for the secretary of state to have in carrying out the provisions of this section and §608.33.

(2) Provided, that railroad, pullman, telephone, telegraph, insurance, banking and trust companies, building and loan associations, cooperative associations, corporations not for profit and corporations paying the maximum capital stock tax, shall be required to furnish the information required under (a) through (i) of subsection (1) hereof only.

(3) All reports herein required shall be for the calendar year and shall be due to be filed on July 1st of each year and the tax payable under §608.33 shall be paid at that time.

608.33 Capital stock tax. —

(1) Every corporation, except railroad, pullman, telephone, telegraph, insurance, banking and trust companies, building and loan associations, cooperative marketing associations and corporations not for profit, doing business in this state shall pay to the state for the use of the state a capital stock tax according to the following schedule:

SCHEDULE FOR CAPITAL STOCK TAX

For all corporations with capital stock not exceeding \$10,000.00	10.00
For capital stock of over \$10,000.00 and not over \$25,000.00	25.00
For capital stock of over \$25,000.00 and not over \$50,000.00	50.00
For capital stock of over \$50,000.00 and not over \$100,000.00	75.00
For capital stock of over \$100,000.00 and not over \$200,000.00	100.00
For capital stock of over \$200,000.00 and not over \$500,000.00	200.00

For capital stock of over \$500,000.00 and not over \$1,000,000.00	500.00
For capital stock of over \$1,000,000.00 and not over \$2,000,000.00	750.00
For capital stock of over \$2,000,000.00	1,000.00

The capital stock above mentioned refers to the invested capital represented by shares of stock outstanding.

(2) In the case of any Florida corporation having been organized or any foreign corporation which has been authorized to do business in Florida, less than twelve (12) months at the time the report is due and the capital stock tax is to be paid, the tax due that year shall be pro rated according to the number of months the corporation has been in existence or authorized to do business in this state.

(3) Nothing in this section or in §608.32 shall apply to any corporation that has been adjudged bankrupt or dissolved by order of court except that any such corporation shall file a statement setting forth its status to that respect, but shall not be required to pay the capital stock tax.

(4) In the event any of the shares of stock of any such corporation should be no par value, then for the purposes of this section, each share shall be presumed to have value of at least one hundred dollars (\$100.00) per share, which presumption may be overcome by actual proof submitted to the secretary of state. The secretary of state shall make such investigation as he may consider necessary and increase or decrease the value of no par value stock as he may determine to be correct; and in so doing he may take into consideration all facts tending to show the fair market value of the stock, including its sale price, the amount of the surplus of the corporation and such other pertinent facts as he may deem advisable.

608.34 Duties of secretary of state. — The secretary of state shall prescribe the form and furnish the blanks upon request to make the annual reports called for in §608.31, examine the reports when received and if the information called for is given in such reports, he shall file the same as information and keep such reports as public records. He shall pay into the state treasury to be used for such purposes as the legislature may determine all moneys collected under the provisions of §608.33. He shall cause a notice of the requirements of §608.32-608.33, to be mailed to the last known address of every corporation doing business in the state which shall fail to file within thirty (30) days after July 1st, the report required by §608.32 or pay the capital stock tax imposed by §608.33.

608.35 Penalty for failure to file report and pay tax. — Any corporation failing to comply with the provisions of §608.32 and §608.33 for six (6) months shall not be permitted to maintain or defend any action in any court of this state until such reports are filed and all taxes due under this chapter be paid.

(2) Provided, that railroad, pullman, telephone, telegraph, insurance, banking and trust companies, building and loan associations, cooperative associations, corporations not for profit and corporations paying the maximum capital stock tax, shall be required to furnish the information required under (a) through (j) of subsection (1) hereof only.

608.35. 

AMENDMENT TO CERTIFICATE OF INCORPORATION

The undersigned President and Secretary of POMPANO SURF CLUB, INC., a Florida corporation, hereby certify that the following resolution was duly adopted by the Board of Directors of said corporation at a meeting held in accordance with the By Laws of said corporation and that the said resolution was proposed by the Board of Directors to the stockholders of said corporation at a meeting whereof proper notice was given to all stockholders and at which a quorum was present, and that the said resolution was duly approved by the stockholders at the said meeting by a majority of the votes present:

"RESOLVED that ARTICLE VII of the Certificate of Incorporation of this Corporation be and the same is hereby amended in its entirety to read as follows:

ARTICLE VII

DIRECTORS

Section 1. The number of directors of this Corporation shall be seven. The said directors shall be elected by the stockholders for terms hereinafter specified at annual meetings as hereinafter set forth, by plurality vote with each stockholder being entitled to vote in person or by proxy and being entitled to as many votes as shall equal the number of shares of stock owned by said stockholder multiplied by the number of directors to be elected. Each stockholder may cast all of such votes for a single

director or may distribute them among the number to be voted for or any two or more of them as the stockholder may see fit. At the annual meeting held during the year 1972 there shall be elected two directors who shall serve for a term of one year or until their successors shall have been duly qualified; two directors who shall serve for a term of two years or until their successors shall have been duly qualified; and three directors who shall serve for a three-year term or until their successors shall have been duly qualified. Separate elections shall be conducted for each such classification of directors. Thereafter, the term of office for each director elected shall be three years and the number of directors to be elected at each annual meeting shall be equal to the number of directors whose terms shall expire at that time. Each director must be a stockholder of the corporation. A person holding stock in the corporation jointly with another person shall be considered a stockholder for purposes of this provision. In case of joint ownership of stock of the corporation, the joint owners shall select one of the joint owners to vote the shares so jointly owned. No stockholder who shall have previously been a director of this corporation shall be eligible to be re-elected or appointed a director until at least one year shall have elapsed since the expiration of such stockholder's most recent term as a director. In the event of a vacancy occurring in the Board of Directors for any reason whatsoever, the remaining directors shall appoint an eligible stockholder to serve as director for the unexpired term.

Section 2. There shall be four regular directors' meetings held each year on the first Mondays in March, June, September and December. Additional meetings of the Board of Directors shall be held when called by the President or by a majority of the Board of Directors, upon three days' notice in writing to each member of the Board, to be mailed to him at his designated post office address, or upon personal notification by telephone or direct word of mouth twenty-four hours in advance of said meeting; provided, however, that when all of the members of such Board of Directors shall be present at any meeting however called or notified, or shall sign their written consent thereto in the record of such meeting, the acts of such meeting shall be valid the same as if such meeting had been legally called. All meetings of the Board of Directors shall be held at the principal office of the corporation unless the directors unanimously consent to the meeting being held elsewhere. At the regular directors' meetings held in the months of June and September of each year three directors shall constitute a quorum. At all other regular or special meetings the majority of the entire Board shall be considered a quorum for the purpose of transacting business. For purposes of approving the transfer of stock of the corporation and the living unit identified therewith, the directors may take action by mail according to such procedures as they may establish and such actions shall be equally as valid as if the action were taken at a duly called meeting of the Board of Directors."






