ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION

Citrus and Chemical Bank, a banking corporation organized and existing under the laws of the State of Florida, hereby certifies that the following Amendment to its Articles of Incorporation was approved on May 27, 1998 by written consent of Citrus and Chemical Bancorporation, Inc., the sole shareholder of the corporation, pursuant to Sections 607.1003(6) and 607.0704, Florida Statutes:

Article II of the corporation's Articles of Incorporation is deleted in its entirety, and the following is substituted in its place:

## ARTICLE II

The general nature of the business to be transacted by the corporation shall be that of a general commercial banking and trust business with all the rights, powers and privileges granted and conferred by the Florida Banking Code regulating the organization, powers and management of banking corporations.
