## ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF NORTHEAST FLORIDA TELEPHONE COMPANY

Pursuant to the provisions of Section 607.1006 of the Florida Statutes, NORTHEAST FLORIDA TELEPHONE COMPANY, adopts the following Article of Amendment to its Articles of Incorporation.

1. Article VII of the Articles of Incorporation is amended to read:
