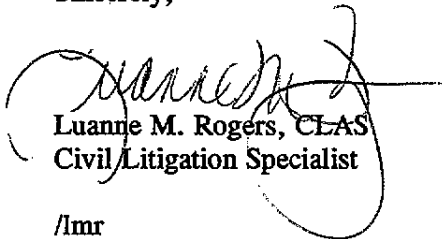

**ARTICLES OF AMENDMENT
OF

1. Article I of the Articles of Incorporation is hereby revoked and the following Article I is inserted in lieu thereof:

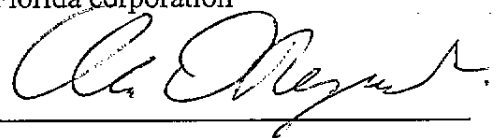
"ARTICLE I"
