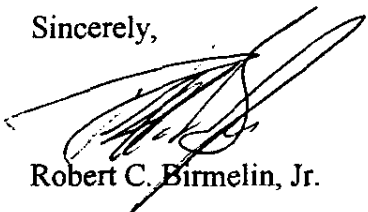
Tyrone,
