FIRST: The name of the Corporation is HIGHLANDS COUNTY LAND & TITLE COMPANY.

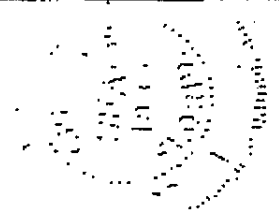
SECOND: The dissolution was authorized on April 14, 1999.
