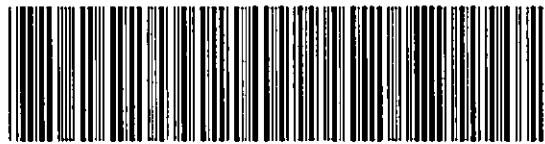

CERTIFICATE OF INCORPORATION
OF
SUN-ART DECORATORS, INC.

We, the undersigned, hereby associate ourselves together for the purpose of becoming a corporation under the laws of the State of Florida, by and under the provisions of the Statutes of the State of Florida, providing for the formation, liabilities, rights, privileges and immunities of a corporation for profit.

ARTICLE I

The name of this corporation shall be SUN-ART DECORATORS, INC.

ARTICLE II

The general nature of the business and the objects and purposes proposed to be transacted and carried on, are to do any and all of the things herein mentioned, as fully and to the same extent as natural persons might or could do, viz:

1. To engage in any commercial and industrial enterprise calculated or designed to be profitable to this corporation and in conformity with the laws of the State of Florida.
2. To generally engage in, do, and perform, any enterprise, act, or vocation that a natural person might or could do or perform.
3. To engage in the manufacture, sale, purchase, importing and exporting of merchandise and personal property of all manner and description, to act as agents for the purchase, sale, and handling of goods, wares, and merchandise of any and all types and descriptions for the accounts of the corporation as factor, agent, procurer, or otherwise for or on behalf of another.

4. To carry on and conduct the business of general painting, decorating, and waterproofing contractors and decorators and of making, performing, and discharging contracts therefor, or relating thereto, or connected therewith, both as contractor and subcontractor, and all allied and interdependent lines of business.

5. To engage in a general contracting business, with particular reference to painting, decorating and waterproofing of structures, houses, residences, and any other general painting; to do a general painting business, including the mixing, buying, selling, and application of oils, stains, pigments, paints, and colors; and to do such incidental financing as may be connected therewith.

6. To carry on the business of manufacturers of and dealers in paints, varnishes, and all other things which can be conveniently manufactured or dealt in by persons carrying on any of the above businesses, and either wholesale or retail, and either as principals or as agents.

7. Generally to make and perform contracts of any kind and description, and for the purpose of attaining any of the objectives of the corporation; to do and perform any other act or thing, and to exercise any and all powers which a co-partnership or natural person could do and exercise, and which now are or hereafter may be authorized by law, and generally to do and perform any and all things necessary or incident to the performing and carrying out of the powers herein above specifically delegated or implied.

ARTICLE III

The number of shares of stock of this corporation shall be fifty (50) shares of no par value. All stock shall be fully paid for and non-assessable. All such stock shall be payable in cash, property, labor, or services at a just valuation to be fixed by the Board of Directors.

ARTICLE IV

The amount of capital with which this corporation shall commence business is \$500.00.

ARTICLE V

This corporation shall have perpetual existence.

ARTICLE VI

The initial post office address of the principal office of this corporation in the State of Florida is 1602 Broadway, Riviera Beach, Florida. The Board of Directors may from time to time move the principal office to any other address in Florida. Additional offices may be maintained elsewhere in the State of Florida, or in the United States.

ARTICLE VII

This corporation shall have three (3) Directors, initially. The number of Directors may be increased or diminished from time to time, by by-laws adopted by the stockholders, but shall never be less than three nor more than nine.

ARTICLE VIII

The names and post office addresses of the first Board of Directors of this corporation, who shall hold office for the first year or until their successors are chosen, shall be:

ARTICLE X

These articles of incorporation may be amended in the manner provided by law. Every amendment shall be approved by the Board of Directors, proposed by them to the stockholders, and approved at a stockholders' meeting by a majority of the stock entitled to vote thereon.

ARTICLE XI

The following provisions shall govern this corporation:

1. The time and place of the annual stockholders meeting shall be fixed and provided in the by-laws and notice of the same shall be given in one of the methods provided by law. Any stockholder or director may waive notice of the time, purpose, or place of any meeting either before, at, or after such meeting.

2. The Board of Directors shall have the power to appoint by resolution an Executive Committee of the (2) or more members, who, to the extent provided in the resolution or in the by-laws of this corporation, shall have and may exercise the power of the Board of Directors in the management of the affairs and property of this corporation and the exercise of the corporate powers.

3. Meetings of the stockholders or directors may be held either within or without the State of Florida.

4. There shall be a President of this corporation who shall also be a Director, and there shall be a Secretary and a Treasurer. They shall be chosen by the Board of Directors and

shall hold office subject to the laws of the State of Florida or until their successors are elected and shall qualify. This corporation may also have such other officers, agents and factors as may be deemed necessary and provided for in the by-laws. All officers, agents and factors shall be chosen in such manner and perform such duties as may be prescribed by the by-laws. All officers, agents and factors shall be chosen in such manner and perform such duties as may be prescribed by the by-laws or determined by the Directors. ANNUAL CORPORATION CAPITAL STOCK TAX LAW

603.32 Annual report of corporations; contents.—

(1) All corporations heretofore or hereafter incorporated in this state and all foreign corporations heretofore or hereafter authorized to do business in this state are required to file with the secretary of state on or before July 1st of each year a sworn report, on such form as the secretary of state shall prescribe, giving (a) the name of each officer and director and his post office address, (b) the home office of the corporation, (c) the name and address of the resident agent upon whom service of process may be made, (d) the main line of business engaged in by the corporation, (e) the date of the last meeting of its board of directors, (f) whether the corporation has been actively engaged in business during the previous twelve (12) months or if its charter powers have been dormant and unused during that period, (g) the number of the shares of the capital stock of such corporation with the par value thereof, (h) the total amount of capital stock, and if a foreign corporation the amount of its capital stock allocated for use in the State of Florida, (i) such other information as may be needed to show whether the corporation is active or inactive, and (j) such other information as may be necessary for the secretary of state to have in carrying out the provisions of this section and 6003.33.

(2) Provided, that railroad, pullman, telephone, telegraph, insurance, banking and trust companies, building and loan associations, cooperative associations, corporations not for profit and corporations paying the maximum capital stock tax, shall be required to furnish the information required under (a) through (l) of subsection (1) hereof only.

(3) All reports herein required shall be for the calendar year and shall be due to be filed on July 1st of each year and the tax payable under 6003.33 shall be paid at that time.

603.33 Capital stock tax.—

(1) Every corporation, except railroad, pullman, telephone, telegraph, insurance, banking and trust companies, building and loan associations, cooperative marketing associations and corporations not for profit, doing business in this state shall pay to the state for the use of the state a capital stock tax according to the following schedule:

The capital stock above mentioned refers to the invested capital represented by shares of stock outstanding.

(2) In the case of any Florida corporation having been organized or any foreign corporation which has been authorized to do business in Florida, less than twelve (12) months at the time the report is due and the capital stock tax is to be paid, the tax due that year shall be pro rated according to the number of months the corporation has been in existence or authorized to do business in this state.

(3) Nothing in this section or in 6003.32 shall apply to any corporation that has been adjudged bankrupt or dissolved by order of court except that any such corporation shall file a statement setting forth its status in that respect, but shall not be required to pay the capital stock tax.

(4) In the event any of the shares of stock of any such corporation should be no par value, then for the purposes of this section, each share shall be presumed to have value of at least one hundred dollars (\$100.00) per share, which presumption may be overcome by actual proof submitted to the secretary of state. The secretary of state shall make such investigation as he may consider necessary and increase or decrease the value of no par value stock as he may determine to be correct; and to so doing he may take into consideration all facts tending to show the fair market value of the stock, including its sale price, the amount of the surplus of the corporation and such other pertinent facts as he may deem advisable.

603.34 Duties of secretary of state.—The secretary of state shall prescribe the form and furnish the blanks upon request to make the annual reports called for in 6003.32, examine the reports when received and if the information called for is given in such reports, he shall file the same as information and keep such reports as public records. He shall pay into the state treasury to be used for such purposes as the legislature may determine all money collected under the provisions of 6003.33. He shall cause a notice of the requirements of 6003.32-6003.33, to be mailed to the last known address of every corporation doing business in the state which shall fail to file within thirty (30) days after July 1st, the report required by 6003.33 or pay the capital stock tax imposed by 6003.33.

603.35 Penalty for failure to file report and pay tax.—Any corporation failing to comply with the provisions of 6003.32 and 6003.33 for six (6) months shall not be permitted to maintain or defend any action in any court of this state until such reports are filed and all taxes due under this chapter be paid.

TO CORPORATION ADDRESSED:

Corporation Capital Stock Tax is due July first each year. On the inside of the form herewith you will find the law in full. In filling out the form be sure and show all information provided for. Do not overlook showing the number of shares of stock issued and outstanding, and in case of shares of no par, show the amount actually invested in all outstanding shares, including any paid in surplus and any surplus set aside as part of the invested capital.

The corporation law requires that each and every corporation shall have not less than three directors, and be sure and show this number on the form.

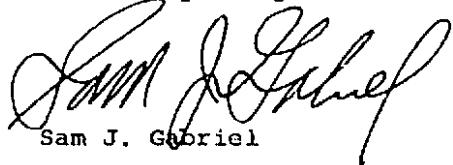

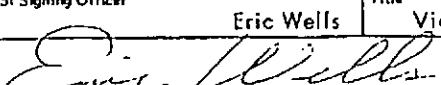

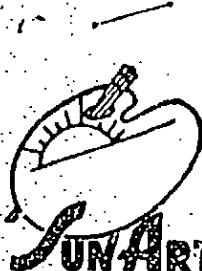
