ARTICLES OF AMENDMENT OF MCCORD-PETELLE, INC.

The Articles of Incorporation of MCCORD-PETELLE, INC., are hereby amended as follows:

The maximum number of shares of stock that this Corporation is authorized to have outstanding at any one time is 100 shares of common stock, of which 6 shall be voting and 94 shall be non-voting, all having no par value.
