## ARTICLES OF AMENDMENT OF THE ARTICLES OF INCORPORATION OF PANAMA MARINE, INC.

Under the provisions of F.s. 607.1006, this corporation adopts the following articles of amendment to its articles of incorporation:

1. The aggregate number of shares of capital stock which the corporation shall be authorized to issue is as follows:

100 shares of voting common stock having a par value of \$1.00 per share.

900 shares of non-voting common stock having a par value of \$1.00 per share.

- 2. All outstanding shares at the time of adoption of this amendment shall be cancelled upon exchange of each ten (10) outstanding shares for one voting share and nine (9) non-voting shares.
- 3. The date of adoption of the amendment was August 19, 1999.
- 5. The amendment was adopted and approved by the shareholders. The number of votes cast for the amendment was sufficient for approval.


