OF

1. The name of the Corporation is A.A.A. ALUMINUM STAMPING, INC.
2. The following amendments to the Articles of Incorporation were adopted by the shareholders of the Corporation on January 30, 2001, in the manner prescribed by the Florida General Corporation Act.:
