Dear Sir or Madam:

Received your 60 day notice today. We wish to take advantage of the waiver described in paragraph one of "Frequently Asked Questions".

A review of your records will show that Cypress Press has always paid their corporation filing fee in the middle of the month of April every year.

Your business report form is mailed to the Maine address during the winter months, and during the winter months I am in Florida. Normally the mail is forwarded to me without a problem. But, apparently last winter the report was not forwarded. This happens quite often to my mail during the winter, especially with mail that has a look like the Florida Report.


Also, I use a "tickler" file to remind me of important business dates. This should have alerted me to pay the corporation fee. However, during the month of April we suffered several physical problems, which caused me to overlook this payment.

Considering our record of compliance over the years, and the fact that the Report never reached me in Florida, and that during April there were several physical problems, I would respectfully request that the Cypress check for \$150.00, which is enclosed, be accepted as payment in full.

I believe that this letter, completed form, and enclosed check which has been mailed by return mail, should qualify for the waiver described on the last page of your instructions—paragraph 1 of "Frequently Asked Questions".
