ARTICLES OF INCORPORATION

OF

1. Pursuant to the provisions of Florida law, the undersigned Corporation adopts the following Amended and Restated Articles of Incorporation:

ARTICLE I

The name of the corporation is SUEZ MOTEL, INC.

ARTICLE II Duration

This corporation shall have a perpetual existence, unless dissolved according to law and, commenced on the 14^{th} day of February, 1963.

ARTICLE III

This corporation is organized for the purpose of transacting any or all lawful business for which corporations may be incorporated under the Florida Business Corporation Act.

ARTICLE IV Capital Stock
