ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF GLENROYAL ENTERPRISES, INC.

- 4. The number of shares voted in favor of such Amendment was one hundred (100), and the number of shares voted against such Amendment was none.
- 5. This Amendment shall become effective immediately upon filing with the Department of State of Florida.
