**Amendments Adopted:**

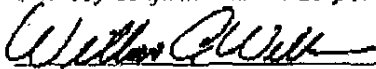
1. **Mailing Address of Corporation.** The mailing address of the corporation shall be changed from 1224 NE 24<sup>th</sup> Street, Fort Lauderdale, FL 33305 to: 404 East Atlantic Boulevard, Pompano Beach, FL 33060, c/o William Webb.
2. **Registered Agent.** The Registered agent shall be changed from Peter Yawt to William A. Webb, Personal Representative of the Estate of Peter Yawt, deceased.
3. **Street Address of Registered Agent.** The Street Address of the Registered Agent shall be changed from 1224 NE 24<sup>th</sup> Street, Fort Lauderdale, FL 33305 to 404 East Atlantic Boulevard, Pompano Beach, FL 33060.
4. **Directors:** The number of Directors at any time shall be at least one or may be more, as determined by the shareholders.
5. **Directors:** Louis D. Haines and Mary Yawt shall be removed as Directors of the corporation. William A. Webb, Personal Representative of the Estate of Peter Yawt, deceased, shall act as the sole director of the corporation.
6. **Officers:** Mary Yawt shall be removed as Vice President of the corporation. William A. Webb, Personal Representative of the Estate of Peter Yawt, deceased, shall act as the President, Vice President, Secretary and Treasurer of the corporation.
