ARTICLES OF AMENDMENT

TO

ARTICLES OF INCORPORATION

OF

DON GREENE POULTRY, INC.



Article III of the Articles of Incorporation of DON GREENE POULTRY, INC., is amended to read as follows:

ARTICLE III

- 1. The maximum number of shares of stock which this corporation is authorized to issue and have outstanding at one time are Ten Thousand (10,000) shares of common stock, each share having Ten Dollars nominal or par value.
