AMENDMENT TO CERTIFICATE OF INCORPORATION OF

AMERICAN DISH SERVICE COMPANY OF CENTRAL FLORIDA,

American Dish Service Company of Central Florida, Inc., as Florida corporation, under its corporate seal and the hands of its President, Bruce E. Gilbert, and Secretary, Debra A. Golden, hereby certifies that:

The Board of Directors of American Dish Service Company of Central Florida, Inc., at a meeting called and held on December 24, 1997, adopted the following resolution:

"BE IT RESOLVED by the Board of Directors of American Dish Service Company of Central Florida, Inc., a Florida corporation, that said Board deems it advisable and hereby declares it to be advisable that Article Eleven be added to the Certificate of Incorporation so as to read as follows:

ARTICLE ELEVEN

The following restrictions are imposed on the transfer of shares of stock of the corporation:

- a) Any stockholder who desires to sell or transfer shares shall first offer them to the corporation, and if the corporation does not purchase, then to any current shareholder.
- b) The price and terms are to be determined by agreement of the stockholder and Board of Directors. If they are unable to agree the stockholder may offer them to anyone who currently owns shares in the corporation.
- c) If agreement cannot be reached with the Board of Directors and current stockholders, then the shares may be transferred to any person who is qualified to be a Subchapter S stockholder.
- d) The foregoing provisions may be waived by the Board of Directors so as to permit the transfer of shares through intestate or testate succession or by gift to a family member of the transferring stockholder provided that the transferee is a qualified Subchapter "S" stockholder.

Any transfer of stock in the Corporation that shall have the effect of terminating or jeopardizing the status of the Corporation as an "S Corporation," as defined in Section 1361 of the Internal Revenue Code of 1986, or any successor legislation of similar import, shall be void ab initio."

Golden, the duly elected Secretary of American Dish Service Company of Central Florida, Inc., do hereby certify that the foregoing Amendment to the Certificate of Incorporation constitutes an amendment to the provisions of the previous Certificate of Incorporation of American Dish Service Company of Central Florida, Inc., as adopted by the Board of Directors of said company.
