**AMENDMENT TO
ARTICLES OF INCORPORATION OF

Pursuant to Section 607.1006(1) of the Florida Statutes, the Articles of Incorporation of Edenfield Plumbing Company, as amended, a Florida corporation (the "Corporation"), are hereby further amended as follows:

1. The name of the Corporation is Edenfield Plumbing Company.
2. Article I of the Articles of Incorporation of Edenfield Plumbing Company is hereby amended to read as follows:

3. Article VI of the Articles of Incorporation of Edenfield Plumbing Company is hereby amended to read as follows:

ARTICLE VI

4. The foregoing amendment was adopted on June 1, 1999, by an action by written consent of the shareholders of this Corporation as authorized by Sections 607.1003(6) and 607.0704 of the Florida Statutes.
