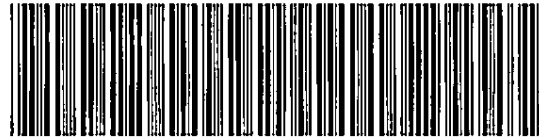

- FIFTH: The Company's net assets remaining after winding up the Company's affairs have been distributed to the Company's shareholders.




