The undersigned subscribers to these Articles of Amendment of John's Plumbing Co. each a natural person and competent to contract are the sole Shareholders of the Corporation and the Sole Directors of the Corporation, and they do make and subscribe these Articles of Amendment and state:

**ARTICLE ONE**

The Corporation was Chartered by the State of Florida on September 15, 1971, and the Charter Number is 388410.
