The undersigned officer of UNIVERSAL MARINE CORP., a Florida corporation, does hereby certify that the Board of Directors of said Corporation approved and proposed to the stockholders thereof the Amendment of ARTICLE I of the Articles of Incorporation of said Corporation, as set out herein, and that thereafter, on the 14TH day of MARCH, 1997, at a special meeting of the stockholders, called and held in compliance with the laws of the State of Florida, and with the Articles of Incorporation and Bylaws of said Corporation, at St. Petersburg, Florida, the stockholders passed and adopted a Resolution amending ARTICLE I of the Articles of Incorporation, so that in lieu of the present provision, said ARTICLE I shall read as follows:
