

(A COOPERATIVE HOUSING CORPORATON)

PALM BEACH COUNTY, FLORIDA

"ARTICLE XX CAPITAL CONTRIBUTION. Simultaneously with the closing upon the purchase by a Purchaser hereunder, the Purchaser shall tender or cause to be tendered payable to the Association, a one-time, non-refundable fee in an amount equal to 12 months of assessment fees. Capital Contribution fees shall increase simultaneously with each increase in monthly assessment in order that the amount of capital contribution shall always equal 12 months of assessment fees. Capital Contributions shall be deposited in reserve accounts for the purpose of increasing the reserves and mitigating against the imposition of special assessments appertaining to capital improvements.
