WE, the undersigned,

Benny Galzon, Jr. and Benny Galzon, Sr.

do hereby associate ourselves together for the purpose of forming a corporation under and by the virtue of the laws of the State of Florida, particularly Chapter 27170, acts of Florida 1953 and acts ammendatary thereto, and under and by virtue of the following articles of incorporation. This corporation to commence March 1, 1974.

ARTICLE I

The name of the corporation is:

The general nature of the business to be translated as follows:
To maintain and operate the construction of residential homes and unrelated business not solely restricted to the maintaining and operating the construction of residential homes as stated above.
