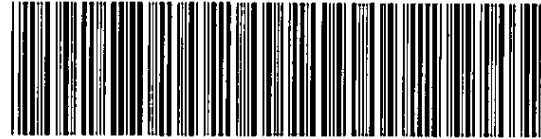

ARTICLES OF INCORPORATION

OF

SUNDOWN, INC.

I, the undersigned subscriber to these Articles of Incorporation, a natural person, do hereby organize and incorporate a corporation for profit under the laws of the State of Florida.

ARTICLE I

The name of the corporation is SUNDOWN, INC.

ARTICLE II

(a) The corporation may engage in any activity or business permitted under the laws of the United States and of this State.

(b) The general nature of the business to be transacted by this corporation is:

To guarantee, endorse, purchase on margin or outright, hold, sell, transfer, mortgage, pledge or otherwise acquire or dispose of the shares of the capital stock of, or any bonds, securities or other evidence of indebtedness created by any other corporation of the State of Florida or any other state or government, and while owner of such stock to exercise all the rights, powers and privileges of

ownership, including the right to vote such stock.

To do any or all of the things herein set forth to the same extent as natural persons might or could do, and in any part of the world as principals, agents, contractors or otherwise, alone or in company with others, and to do and perform all such other things and acts as may be necessary, profitable or expedient in carrying on any of the business or acts above named.

The intention is that none of the objects and powers as hereinabove set forth, except where otherwise specified in this Article, shall be in anywise limited or restricted by reference to or inference from the terms of any other objects, powers or clauses of this Article or any other Articles, but that the objects and powers specified in each of the clauses in this Article shall be regarded as independent objects and powers.

ARTICLE III

The maximum number of shares of stock that this corporation is authorized to have outstanding at any time is One Thousand (\$1,000) shares of common stock, each share having a par value of Ten Cents (\$.10).

Authorized capital stock may be paid for in cash, services or property, at a just value to be fixed by the Board of Directors of this corporation at any regular or special meeting, except that stock issued pursuant to the provisions of Internal Revenue Code 1244 shall be issued only for money or other property (other than stock or securities).

ARTICLE IV

The amount of capital with which this corporation shall begin business is Five Hundred Dollars (\$500.00).

ARTICLE V

The corporation shall have perpetual existence.

ARTICLE VI

The initial street address of the principal office of this corporation is to be at 523 South Washington Boulevard, Sarasota, County of Sarasota, State of Florida. The Board of Directors, stockholder or stockholders may from time to time designate such other street address and place for the principal office of this corporation as it may see fit.

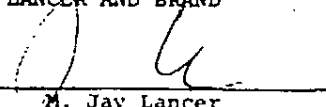

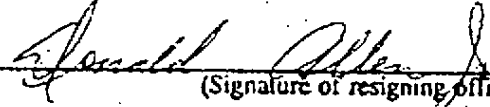
