"Article I - Name"

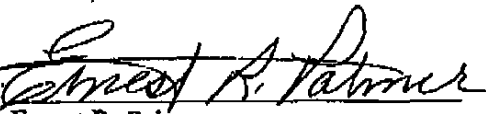
The name of is this Corporation is Ernie Palmer, Inc.
