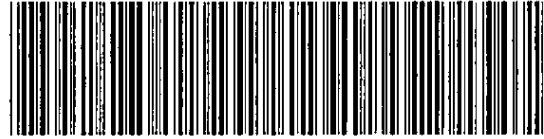

**ARTICLES OF AMENDMENT
TO THE ARTICLES OF INCORPORATION OF
CORTEZ FOOT & ANKLE SPECIALISTS, P.A.**

The undersigned; certifies that:

1. He is the President of **CORTEZ FOOT & ANKLE SPECIALISTS, P.A.**, a Florida corporation, whose Articles of Incorporation were filed with the Secretary of State, State of Florida, on March 3, 1975, as amended.

2.
