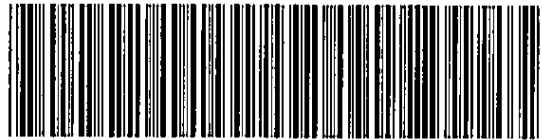

ARTICLES OF INCORPORATION
OF
TOM GRIZZARD REALTOR, INC.

The undersigned subscriber to these Articles of Incorporation, a competent person to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of this corporation is TOM GRIZZARD REALTOR, INC.

ARTICLE II. NATURE OF BUSINESS

This corporation may engage in any activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE III. CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is:

SEVEN THOUSAND FIVE HUNDRED (7,500) shares of
Common Stock having a Nominal or Par Value
of ONE DOLLAR (\$1.00) per share.

The common stockholders of this corporation may enter into written agreements subjecting the disposition or transfer of all or any common stock of this corporation to reasonable restraints by sale, assignment, pledge, will, inter vivos gift, or any other method of transfer or encumbrance of said common stock.

Stockholders may include in their agreements between themselves the following as matters of agreement:

- (1) Any reasonable limitation upon the transferability, assignment, or pledge of said common stock; and/or
- (2) The conferring of pre-emptive rights of purchase upon officers and/or common stockholders as conditions precedent to the sale, assignment, bequest, gift or pledge of said common stock.

In the event that stockholders of this corporation enter into an agreement wherein they impose reasonable restraints upon the transferability of the common stock of this corporation, such stock shall not be eligible for transfer on the books of this corporation, unless and until all of the terms and conditions of such agreement are met.

ARTICLE IV. INITIAL CAPITAL

The amount of capital with which this corporation will begin business is FIVE HUNDRED AND NO/100 (\$500.00) DOLLARS.

ARTICLE V. TERM OF EXISTENCE

This corporation shall begin its existence on the 1st day of April, 1975, and is to exist perpetually thereafter.

ARTICLE VI. ADDRESS

The initial street address of the principal office of this corporation in the State of Florida is 1341 West Griffin Road, Leesburg, Florida.

The Board of Directors may, from time to time, move the principal office to any other address in Florida.

ARTICLE VII. DIRECTORS

This corporation shall have one (1) director, initially. The number of directors may be increased or diminished from time to time by the By-Laws adopted by the stockholders, but shall never be less than one (1) nor more than three (3).

ARTICLE VIII. OFFICERS

This corporation shall have a President, who shall be a Director, and a Secretary-Treasurer, and any other additional officers authorized by its By-Laws.

ARTICLE IX. INITIAL DIRECTORS

ARTICLE XI.
CONDUCT OF BUSINESS OF CLOSE CORPORATION

The business of this corporation may be managed by an Executive Committee of the Directors (such Executive Committee shall be composed of one (1) or more directors); and all action taken by the Executive Committee shall be deemed the

action of the Board of Directors, even though taken without a meeting, if written consent to the action in question is signed by all the members of the Executive Committee and if said signed written consent is filed with the minutes of the proceedings of the Executive Committee; and this shall be true whether the consent is signed and filed before or after the action is so taken.

Any action of the stockholders of this corporation may be taken without a meeting if consent in writing, setting forth the action so taken, shall be signed by all the persons who shall be entitled to vote upon such action at a meeting and filed with the secretary of the corporation as part of the corporate records. Such consent shall have the same force and effect as a unanimous vote of the stockholders. Written agreements as to conduct of certain affairs of the corporation may include the following:

1. The stockholders of this corporation may enter into a written agreement, embodied in the Articles of Incorporation or By-Laws of the corporation, or in a side agreement in writing and signed by all the parties hereto, relating to any phase of the affairs of the corporation, including, but not limited to, the following:

- (a) Management of the business of the corporation.
- (b) Declaration and payment of dividends or division of profits.
- (c) Who shall be officers or directors, or both;

of the corporation.

(d) Restrictions on transfer of stock.

(e) Voting requirements, including the requirements of unanimous voting of stockholders or directors.

(f) Employment of stockholders by the corporation.

(g) Arbitration of issues as to which the stockholders are deadlocked in voting power or as to which the directors are deadlocked and the stockholders are unable to break the deadlock.

2. No written agreement to which stockholders of the corporation have actually assented, whether embodied in the Charter or By-Laws of the corporation or in any side agreement in writing and signed by all the parties thereto, and which relates to any phase of the affairs of the corporation, whether to the management of its business or division of its profits or otherwise, shall be invalid as between the parties thereto, on the ground that it is an attempt by the parties thereto to treat the corporation as if it were a partnership or to arrange their relationships in a manner that would be appropriate only between partners.

3. If the business of this corporation is managed by a Board of Directors, an agreement between all of the stockholders and a party who is not a stockholder, is not invalid, as among the parties thereto, on the ground that it so relates to the conduct of the affairs of the corporation as to interfere with the discretion of the Board of Directors, but the making

of such an agreement shall impose upon the stockholders who are parties thereto the liability for managerial acts that is imposed by the laws of this state upon directors.

ARTICLE XII. INDEMNITY

This corporation shall have power to indemnify any person who was or is a party or is threatened to be made a party to any threatened, pending or completed action, suit or proceeding, whether civil, criminal, administrative or investigative (other than an action by or in the right of the corporation) by reason of the fact that he is or was a director, officer, employee or agent of the corporation, or is or was serving at the request of the corporation as a director, officer, employee or agent of another corporation, partnership, joint venture, trust or other enterprise, against expenses (including attorneys' fees), judgments, fines and amounts paid in settlement actually and reasonably incurred by him in connection with such action, suit or proceeding (or any appeal therein) if he acted in good faith and in a manner he reasonably believed to be in or not opposed to the best interests of the corporation, and, with respect to any criminal action or proceeding, had no reasonable cause to believe his conduct was unlawful. The termination of any action, suit or proceeding by judgment, order, settlement, conviction, or upon a plea of nolo contendere or its equivalent, shall not, of itself, create a presumption that the person did not act in good faith and in a manner which he reasonably believed to be in or not opposed to the

best interests of the corporation, and, with respect to any criminal action or proceeding, had reasonable cause to believe that his conduct was unlawful.

This corporation shall have power to indemnify any person who was or is a party or is threatened to be made a party to any threatened, pending or completed action or suit by or in the right of the corporation to procure a judgment in its favor by reason of the fact that he is or was a director, officer, employee or agent of the corporation, or is or was serving at the request of the corporation as a director, officer, employee or agent of another corporation, partnership, joint venture, trust or other enterprise against expenses (including attorneys' fees) actually and reasonably incurred by him in connection with the defense or settlement of such action or suit or appeal therein, if he acted in good faith and in a manner he reasonably believed to be in or not opposed to the best interests of the corporation and except that no indemnification shall be made in respect of any claim, issue or matter as to which such person shall have been adjudged to be liable for gross negligence or misconduct in the performance of his duty to the corporation unless and only to the extent that the Court of Chancery or the court in which such action or suit was brought shall determine upon application that, despite the adjudication of liability but in view of all the circumstances of the case, such person is fairly and reasonably entitled

to indemnify for such expenses which the Court of Chancery or such other court shall deem proper.

To the extent that a director, officer, employee or agent of this corporation has been successful on the merits or otherwise in defense of any action, suit or proceeding referred to in the two (2) preceding paragraphs or in defense of any claim, issue or matter therein, he shall be indemnified against expenses (including attorneys' fees) actually and reasonably incurred by him in connection therewith.

Any indemnification under this Article (unless ordered by a court) shall be made by the corporation only as authorized in the specific case upon a determination that indemnification of the director, officer, employee or agent is proper in the circumstances because he has met the applicable standard of conduct set forth in this Article. Such determination shall be made (1) by the Board of Directors by a majority vote of a quorum consisting of directors who were not parties to such action, suit or proceeding, or (2) if such a quorum is not obtainable, or, even if obtainable a quorum of disinterested directors so directs, by independent legal counsel in a written opinion, or (3) by the stockholders.

Expenses incurred in defending a civil or criminal action, suit or proceeding may be paid by the corporation in advance of the final disposition of such action, suit or proceeding as authorized by the Board of Directors in the specific case upon receipt of an undertaking by or on behalf of the director,

officer, employee or agent to repay such amount unless it shall ultimately be determined that he is entitled to be indemnified by the corporation as authorized in this Article.

The indemnification provided by this Article shall not be deemed exclusive of any other rights to which those seeking indemnification may be entitled under any by-law, agreement, vote of stockholders or disinterested directors or otherwise, both as to action in his official capacity while holding such office, and shall continue as to a person who has ceased to be a director, officer, employee or agent and shall inure to the benefit of the heirs, executors and administrators of such a person.

This corporation shall have power to purchase and maintain insurance on behalf of any person who is or was a director, officer, employee or agent of the corporation, or is or was serving at the request of the corporation as a director, officer, employee or agent of another corporation, partnership, joint venture, trust or other enterprise against any liability asserted against him and incurred by him in any such capacity, or arising out of his status as such, whether or not the corporation would have the power to indemnify him against such liability under the provisions of this Article.

ARTICLE XIII. SELF DEALING

The Board of Directors is authorized to fix the salaries of the corporate officers and directors regardless of whether or not such directors, in so doing, are fixing their own compensation.

The Board of Directors may fix their own compensation for services rendered by them to the corporation, in whatever capacity.

No contract or transaction entered into by the corporation shall be affected by the fact that a director of the corporation was personally interested in it, if, at the meeting of the Board of Directors, making, authorizing, or confirming such contract or transaction, the interested director discloses his interest therein, and such contract or transaction is adopted or ratified by a majority of a quorum of directors present, exclusive of him.

The directors may submit any contract or transaction for approval at the annual meeting of the stockholders or at any special meeting of the stockholders called for that purpose; and any contract or transaction so approved by a majority vote of a quorum of the stockholders present at such meeting shall be binding upon the corporation and all its stockholders, whether or not the contract or transaction would otherwise be subject to attack because of the interest of any of the directors of the corporation or for any other reason.

ARTICLE XIV.

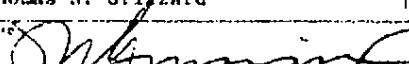
