**CERTIFICATE AS TO AMENDMENT OF
ARTICLES OF INCORPORATION OF
BILL WILLIAMS AIR-CONDITIONING & HEATING, INC.**

We, William H. Williams and Gail R. Terry, hereby certify that we are the President and Secretary, respectively, of Bill Williams Air-Conditioning & Heating, Inc., a Florida corporation. We further certify that the following resolution relating to the amendment of the Articles of Incorporation of said corporation was approved and adopted by unanimous consent by the shareholders and directors of said corporation on this date:

BE IT RESOLVED, that, effective on the date of filing of this amendment with the Secretary of State of Florida, the first paragraph of ARTICLE III of the Articles of Incorporation of this corporation is hereby amended in its entirety to read as follows:

The maximum number of shares of stock that the corporation is authorized to have outstanding at any time shall be one thousand (1000) shares of Common Stock, par value ten dollars (\$10.00) per share. All stock issued shall be fully paid and non assessable. The Stockholders shall have no preemptive rights with respect to the capital stock or securities of the corporation, and the corporation from time to time may issue and sell shares of its capital stock of any class, may issue and grant rights and options to purchase shares of such capital stock and may issue and sell its bonds, notes, debentures and other securities convertible into stock of the corporation without offering such shares, rights or options to purchase shares, bonds, notes, debentures or other securities (whether now or hereafter authorized) to the Stockholders that are holding shares of its capital stock.
