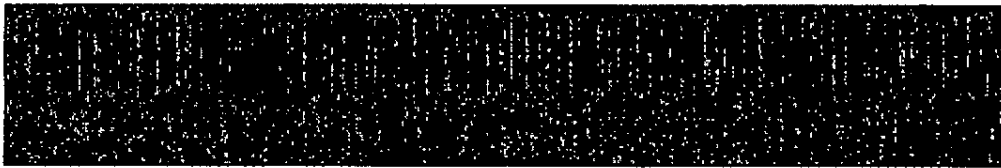

hereby adopts the following amendment to its Articles of Incorporation:

ARTICLE I

Name of Corporation

The name of the Corporation is PDR CERTIFIED PUBLIC ACCOUNTANTS, INC.

ARTICLE II

Amendment

Article III of the Articles of Incorporation of the Corporation is hereby amended in its entirety
so as to read, after amendment, as follows:

"ARTICLE III--CAPITAL STOCK

The authorized capital stock of this Corporation shall be one hundred thousand (100,000)
shares of common stock at a par value of one-one hundredth of a dollar (\$0.01) per share."

This Amendment shall become effective upon filing with the Florida Secretary of State.


