AMENDMENT TO ARTICLES OF INCORPORATION OF THE P.A.

WHEREAS, the Articles of Incorporation of BARR, MURMAN & TONELLI filed with and approved by the Secretary of State of the State of Florida on the 4th day of May, 1977, effective as of May 1, 1977; and

WHEREAS, Amendments to the Articles of Incorporation of BARR, MURMAN & TONELLI, P.A. were filed with and approved by the Secretary of State of the State of Florida on June 29, 1982, March 17, 1986, and August 27, 1990; and

WHEREAS, it is the intention of the directors and the stockholders of BARR, MURMAN & TONELLI, P.A. that the Articles of Incorporation of BARR, MURMAN & TONELLI, P.A. be amended, in accordance with the proposed amendment hereinafter set forth; and

WHEREAS, the proposed amendment to the Articles of Incorporation of BARR, MURMAN & TONELLI, P.A. hereinafter set forth was approved and adopted by all of the directors and by all of the stockholders, comprising the only voting group of stockholders, of BARR, MURMAN & TONELLI, P.A., pursuant to the provisions of Florida Statutes, Section 607.1003(5), on the Z.7 , 2000; and

WHEREAS, the approval of the Secretary of State of the State of Florida of the proposed amendment hereinafter set forth is hereby requested.

NOW, THEREFORE, the Articles of Incorporation of BARR, MURMAN & TONELLI, P.A. are hereby amended by deleting in its entirety the present Article IV, and by substituting therefor the following, to-wit:

"ARTICLE IV

Capital Stock

The total number of shares of capital stock authorized to be issued by the (a) corporation (the "Shares") shall consist of one class only and shall be comprised of 200,000 shares of common capital stock having a par value of \$.01 per share of which (i) 2,000 shares shall be designated voting shares (the "Voting Shares"), entitling the holders thereof to one

(1) vote with respect to all matters to be properly voted on by the stockholders of the corporation, and (ii) 198,000 shares shall be designated non-voting shares (the "Non-Voting Shares"), entitling the holders thereof to no voting rights. Each Voting Share and each Non-Voting Share shall participate equally in all dividends paid by the corporation and in the assets of the corporation upon its liquidation or dissolution. All or any part of the Shares may be paid for in cash, in property, or in labor or services actually performed for the corporation and valued at a fair valuation to be fixed by the Board of Directors at a meeting called for such purpose. All stock when issued shall be paid for and shall be nonassessable.

(b) In the election of directors of this corporation, there shall be no cumulative voting of the stock entitled to vote at such election."
