The undersigned, certifies that:

1. He is the President of MATTHEW J. FINEMAN, D.P.M., P.A., a Florida corporation, whose Articles of Incorporation were filed with the Secretary of State, State of Florida, on June 16, 1977.

2. The following amendment to the Articles of Incorporation was unanimously adopted and approved by the Shareholders and the Board of Directors, by written consent in lieu of a meeting, dated April 11, 2000.
