ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF R.V. WORLD, INC., OF NOKOMIS

Pursuant to the provisions of Section 607.1006, Florida Statutes, this corporation hereby amends its Articles as follows:

ARTICLE I OF AMENDMENT

Article V of the Articles of Incorporation shall be amended by adding the following paragraph:

In addition to the authority to issue fifteen thousand (15,000) shares of common stock with voting rights, this corporation shall also have the authority to issue ten thousand, five hundred sixty-five (10,565) shares of common stock with no voting rights. This non-voting common stock will be equal, share for share, with the voting common stock in all respects except voting rights.
