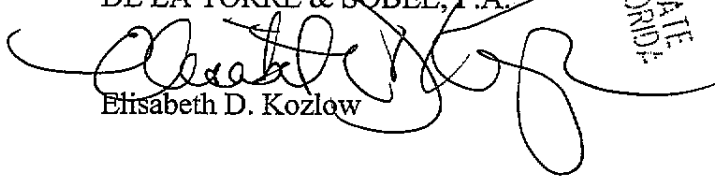

**THIRD:** The amendment was approved by the shareholders. The number of votes cast for the amendment were sufficient for approval.

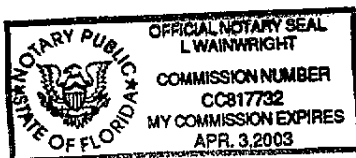
