Pursuant to Florida Statutes Section 607.1005 *et seq.*, Guy B. Bailey, Jr., as president of Bailey Harper Baker Arencibia & Agudo, a professional association, a professional corporation originally organized under the laws of the State of Florida on March 10, 1978, Document #566981, Federal Tax Identification #59-1812683, (the "Corporation") hereby makes, swears, certifies and files the following amendments to the Corporation's articles of incorporation, all of which have been adopted and are effective as of January 21, 1999. These amendments were approved by the unanimous vote of the shareholders and directors held on January 20, 1999.

1. **Change of Name.** The name of the Corporation is hereby amended to be "GBBjr Service Corporation".
2. **Directors.** Beginning January 21, 1999, the sole director of the Corporation shall be Guy B. Bailey, Jr., 300 Courvoisier Centre, 501 Brickell Key Drive, Miami, Florida 33131-2623.
3. **Officers.** Beginning January 21, 1999, the sole officer of the Corporation is as follows: Guy B. Bailey, Jr., President, Secretary and Treasurer, whose address is 501 Brickell Key Drive, Suite 300, Miami, Florida 33131-2623.
4. **Purpose.** Beginning January 21, 1999, the Corporation shall cease to be a professional services corporation pursuant to Florida Statutes Chapter 621 and shall be a for-profit corporation pursuant to Florida Statutes Chapter 607. No further professional services shall be performed by the Corporation.
