ARTICLES OF AMENDMENT
FOR
S. G. & S., INC.

Pursuant to Florida Statutes Section 607.1006, the Articles of Incorporation of the above-named Corporation are hereby amended as follows:

1. Article III is hereby amended to read as follows:

The total number of shares the Corporation is authorized to issue is 100 shares of which 6 shall be voting common stock and 94 shall be non-voting common stock. Each share of the Corporation's stock shall have a par value of \$1.00 per share. Except for voting rights, there shall be no differences in the rights of the holders of voting common stock and non-voting common stock.

2. The foregoing amendment was adopted on May 15, 2006.

3. The number of votes cast for the amendment by the shareholders was sufficient for approval.
