1. Article I, be and it is hereby amended to read as follows:

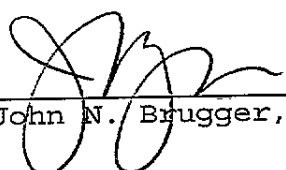
ARTICLE I - NAME
