

ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF LINDA G. HIRSCH, INC.

(Document #585568)

The Articles of Incorporation of Linda G. Hirsch, Inc. are hereby amended as follows:

- 1. The name of the corporation is LINDA G. HIRSCH, INC.
- 2. The name of the corporation is hereby changed to LINDA G. HIRSCH, P.A.
- 3. The purposes for which the corporation is organized are changed to the following:

This Corporation, through its officers and employees and independent contractors, shall be authorized to engage in the practice of psychology and the provision of mental health services pursuant to the licenses which such officers and employees and independent contractors of the Corporation have obtained from the State of Florida; to engage in any activities which will facilitate and promote the practice of psychology and the provision of such mental health services through the Corporation's officers and employees and independent contractors; to invest the Corporation's funds in real estate, mortgages, stocks, bonds and any other type of investments within the meaning of Florida Statutes Section 621.08 of the Professional Service Corporation Act; and to purchase and own real and personal property necessary for the rendering of mental health services. This Corporation shall not be authorized to engage in any business other than the practice of psychology and the provision of mental health services.
