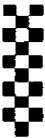

TO
ARTICLES OF INCORPORATION

1. The Name of the corporation is: Radiology Associates of Ocala, P.A. (the "Company").

2. The date of filing of the Articles of Incorporation of the Company was May 7, 1970 and amended on June 2, 1975, March 27, 1979 and March 21, 1994 and assigned document number 602079.

3. The Company amends its Articles of Incorporation by amending Article I. Article I is deleted in its entirety and the following is substituted therefore:

**"ARTICLE I
NAME**


The name of the corporation is Radiology Imaging Associates, P.A. (the "Company")."
