2. Article I of the Articles of Incorporation of DIAMOND, HORSBURGH & SCHONFELD, M.D., P.A., is hereby amended to read:

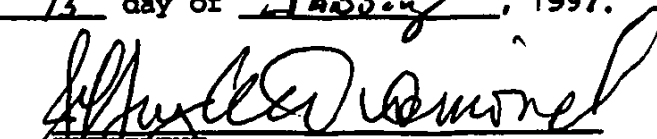
