1. The name of the corporation is ST. VINCENT'S'S PATHOLOGY ASSOCIATES,

2. Article I of the Articles of Incorporation of ST. VINCENT'S'S PATHOLOGY
ASSOCIATES, MATTHEW C. PATTERSON, M.D., P.A., a Florida corporation, is hereby
amended in its entirety to read as follows:

ARTICLE I - NAME

"The name of this corporation is ST. VINCENT'S'S PATHOLOGY
ASSOCIATES, P.A."

3. Article III of the Articles of Incorporation of ST. VINCENT'S'S PATHOLOGY
ASSOCIATES, MATTHEW C. PATTERSON, M.D., P.A., a Florida corporation, is hereby
amended in its entirety to read as follows:

"CAPITAL STOCK

This corporation is authorized to issue Ten Thousand (10,000) shares of
