ARTICLE I is amended as follows:

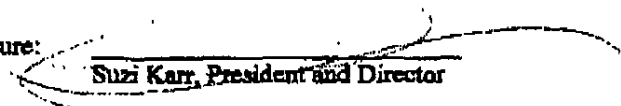
ARTICLE I NAME
